Prospective Member Information Sheet

If, after reading this Information Sheet, you wish to apply for membership please complete the attached Application for Probationary Membership form and hand or send it to the CAG office.

The CAG Membership Fee provides for the day to day running cost, electricity, rent and general administration of CAG and provision of services to members.

CAG Membership entitles you to discounted instructional classes, use of all equipment (some conditions and fees apply), after-hours access for full members (by contacting one of the designated keyholders), and the chance to enter your art/craft work in Members' Exhibitions and display and sell work in the Courtyard Gallery and shop as well as at various Sales of Work, etc. held during the year.

Members receive regular newsletters, so that they are kept up to date with what is happening at the Centre.

To become a member you can either be proposed by an existing member or provide two referees.

Note: Membership fee is non refundable, unless the Candidate's membership application is not accepted by Committee.

Probationary membership is for the period of three months. This still enables you to participate in classes at members' rates and enter your art/craft work in Members' Exhibitions and/or place items for sale in the shop, as well as participating in any Sales of Work held during this time. You can also use the Centre's equipment - *but only during the Centre's office hours*. (However an in-service is required before you have use of some of the equipment and some fees apply so please check with the Co-ordinator for full information.)

Sale of Work and Community Displays

The group has Sales of Work and Community Displays at various venues including the Canning Arts Centre. Members placing work in these sales are required to do a minimum of one roster per sale. Members are able to place items for sale in the Gift Shop and/or Gallery. Such items must have, where practicable, a CAG Tag attached. These are available from the office at no cost.

A 20% commission on sales is deducted and paid to CAG. All members wishing to sell work through the gallery or other sales must supply CAG with **either notification of ABN or Statement by a Supplier** to comply with Australian Taxation Office requirements. Failure to do this will mean that an additional 48.5% will be withheld and forwarded to the Taxation Department.

When there are Sunday Openings of the Gallery and Shop, members exhibiting work are expected to make themselves available for a Supervision Roster as required. Please note that members not participating in Sales or in Exhibitions can also expect to be asked to do one roster per year when necessary to assist in the smooth running of CAG.

Each new member is encouraged to think about becoming a Committee member to keep our committee active and vital to help ensure the group is kept going for all its members.

Any contribution in any way is welcomed.
